4.	 Budget & Finance Budget Update- VW circulated an updated budget and cashflow forecast for this financial year. There are two amendments to the circulated budget update- the £10k for the AST tags will be removed from the P&L and will be paid from reserves. In addition, there is a reduction of £4.5K in budgeted income from the Job Retention Scheme, as the bailiffs returned to work full time earlier than anticipated. This results in a projected loss at the yearend of £11,400. The board agreed in November 2020 to reduce the levy from 46p to 42p in the £ to result in a loss for this year as the previous financial year closed with a surplus of circa £18k. VW will circulate the corrected budget with the minutes of this meeting. Annual Accounts to January 2021- are still in preparation but will be circulated to the board for amendment and approval. They have been delayed by the setting up of a new bookkeeping process which will allow for less duplication of data entry and more accurate financial forecasting. 	vw vw

VW will circulate copies to the board with minutes of the meeting. Biosecurity- RL requested that any agricultural contractors be encouraged to clean machinery used near the river to prevent GH seed contamination, where relevant. Pacific Pink salmon have not been reported from the Findhorn but have been seen elsewhere. Red vent has been reported from the Findhorn.
